

Fair Housing in New Mexico



Fair housing is the right for everyone to have access to safe housing opportunities without discrimination based on race, religion, national origin, sex, color, familial status or disability. The New Mexico Human Rights Act also prohibits discrimination on the basis of ancestry, sexual orientation, gender identity, spousal affiliation and pregnancy, childbirth or related condition. If you think your rights have been violated, you may contact the U.S. Department of Housing and Urban Development (HUD) Office of Fair Housing and Equal Opportunity office in Fort Worth (below) or file a complaint online.

Where to WRITE or CALL

- Send a letter to the HUD office nearest you (listed below), or you may call that office directly.
- Persons who are deaf or hard of hearing and use a TTY, may call those offices through the toll-free Federal Information Relay Service at 711.

What to Provide to HUD

- Your name and address
- The name and address of the person your complaint is against (the respondent)
- The address or other identification of the housing involved
- A short description of the alleged violation (the event that caused you to believe your rights were violated)
- The date(s) of the alleged violation
